#### BURNETT COUNTY COMPREHENSIVE PLANNING PUBLIC OPINION SURVEY

#### Town of Dewey

During the summer of 2009, the Survey Research Center (SRC) at the University of Wisconsin – River Falls sent comprehensive planning public opinion surveys to 135 residents and property owners in the Town of Dewey. A total of 50 questionnaires were returned for a return rate of 37 percent. This number of returned surveys will provide estimates that are expected to be accurate to within plus or minus 13 percent.


