## BURNETT COUNTY COMPREHENSIVE PLANNING PUBLIC OPINION SURVEY

## Town of Union

During the summer of 2009, the Survey Research Center (SRC) at the University of Wisconsin – River Falls sent comprehensive planning public opinion surveys to 130 residents and property owners in the Town of Union. A total of 52 questionnaires were returned for a return rate of 40 percent. This number of returned surveys will provide estimates that are expected to be accurate to within plus or minus 13 percent.


