BURNETT COUNTY COMPREHENSIVE PLANNING PUBLIC OPINION SURVEY

Village of Webster

During the summer of 2009, the Survey Research Center (SRC) at the University of Wisconsin – River Falls sent comprehensive planning public opinion surveys to 128 residents and property owners in the Village of Webster. A total of 54 questionnaires were returned for a return rate of 42 percent. This number of returned surveys will provide estimates that are expected to be accurate to within plus or minus 12 percent.


